1. The undersigned Bidder agrees, if this Bid is accepted, to enter into an agreement with Owner, in the form included in the Procurement Documents, to perform and furnish the Work as specified or indicated in the Procurement Documents for the Bid Price and within the Bid Times indicated in this Bid and in accordance with the other terms and conditions of the Contract Documents.
2. In submitting this Bid, Bidder represents, as more fully set forth in the Agreement, that:
  - a. This Bid will remain subject to acceptance for sixty (60) days after the day of Bid opening; Alternate Bids will remain subject to acceptance for sixty (60) days after the signing of the Agreement, if a contract is awarded on the basis of this bid, and if the bidder does not execute an agreement for any reason, other than as authorized by law, the bidder and the bidder's Surety are liable to the Owner as provided in the Ohio Revised Code as applicable to the Owner.
  - b. The Owner has the right to reject his Bid;
  - c. Bidder accepts the provisions of the Instructions to Bidders regarding disposition of Bid Security;
  - d. Bidder will sign and submit the Agreement with the Bonds and other documents required by the Bidding Requirements within 10 days after the date of Owner's Notice to Award;
  - e. Bidder has examined copies of all the Procurement Documents, and agrees to comply with all requirements of the Contract Documents, regardless of whether the bidder has actual knowledge of the requirements and regardless of any statement or omission made by the bidder which might indicate a contrary intention.
  - f. Bidder has visited the site and become familiar with the general, local, and site conditions, and has correlated personal observations about the requirements of the Procurement Documents.
  - g. Bidder is familiar with, and will comply with all federal, state and local laws and regulations;
  - h. Bidder has correlated the information known to Bidder, information and observations obtained from visits to the site, reports and drawings identified in the Procurement Documents and additional examinations, investigations, explorations, tests, studies, and data with the Procurement Documents.
  - i. Bidder and each person signing on behalf of the bidder certifies, and in the case of a joint combined bid, each party thereto certifies as to such party's organization, under penalty of perjury, that the best of the undersigned's knowledge and belief: (a) the base bid, any unit prices and any alternate bid in the bid have been arrived at independently without collusion, consultation, communication, or agreement, for the purpose of restricting competition as to any matter relating to such base bid, unit prices, or alternate bid with any other bidder; (b) unless otherwise required by law, the base bid, any unit prices and any alternate bid in the bid have not been disclosed by the bidder and will not be disclosed by the bidder prior to the bid opening, directly or indirectly, to any other bidder who would have any interest in the base bid, unit prices, or alternate bid; (c) no attempt has been made or will be made by the bidder to induce any individual, partnership or corporation to submit or not to submit a bid for the purpose of restricting competition.
  - j. Bidder understands that the award of separate contracts for the project will require sequential, coordinated, and interrelated operations which may involve, interference, disruption, hindrance, or delay in the progress of the bidder's work.

- k. Bidder certifies that upon the award of this contract, it will make a good faith effort to ensure that all of its employees, will work on the site of the Project, will not purchase, transfer, use, or possess illegal drugs or alcohol or abuse prescription drugs in any way.
- l. Bidder agrees to furnish any information requested by Owner to evaluate the responsibility of the bidder.
